## Election Rules and Regulations of National Neonatology Forum of Delhi

1. Only life members of NNF INDIA from Delhi shall be eligible to offer themselves as candidates for elections or to propose or second the candidature of any member or participate in voting at the election.
2. A member can seek election for only one post.
3. The election of the office bearers of the society shall be by Electronic Ballot (ONLINE).
4. Nominations shall be duly proposed and seconded by eligible members of the society and consented to by the candidates concerned.
5. All the particulars contained in the Nomination Paper should be correctly filled up.
6. Photos of candidate and both the proposers should be self-attested.
7. Candidate and both the proposers should submit a self-attested copy of photo ID with nomination.
8. Nomination paper duly filled in all respect, should be scanned and submitted in "PDF FORMAT" at NNF Delhi office to the email address (given below) by the stipulated time & date not later than 4.00 p.m. on 31<sup>st</sup> December 2021. Hard Copy (Speed post/Faxed) will be treated as "Invalid".

9. Any member who has any complaint about the election shall give the same in writing to the above email addressed to Secretary within 21 days of the declaration of results. An election tribunal nominated by the Governing Body shall go into the complaints and the decision of the tribunal shall be final. In case a member of the tribunal be involved himself in any way in such a dispute, he shall not be a member of the tribunal.

As per the clause no. 8 of the constitution of the NNF Delhi, following is the eligibility criteria of the candidates.

## **8- Eligibility Criteria for Office Bearer Candidates:**

### **8.1 President**

Shall be a Life-member of NNF for more than Ten completed years. The candidate for President elect shall have submitted his/her accounts pertaining to any of the projects/Program of NNF before filing his/her nomination.

### **8.2 Vice – President**

Shall be a Life-Member of NNF for more than Ten completed years. The candidate for Vice- President should have submitted his/ her accounts pertaining to any of the projects / Programs of NNF before filing his / her nomination.

### **8.3 Secretary**

Shall be a Life Member of NNF for more than EIGHT completed years. The Candidate for Secretary General Shall have submitted his/her accounts pertaining to any of the projects/Program of NNF before filing his/her nomination

### **8.4 Joint Secretary and Treasurer**

Shall be a Life Member of NNF for more than SIX completed years. The candidate for Treasurer shall have submitted his/her accounts pertaining to any of the projects/Program of NNF before filing his/her nomination.

### **8.5 Member Executive Board elected**

Shall be a life member of NNF for more than Five Years
