Inviting Proposal for E-voting in NNF Elections 2022

As per the Memorandum of Association of the organization, election to the posts of Office bearers and Executive Board are due in 2022 and to be completed by 20th November 2022. The bid award is expected to be completed by 7th September 2022. The firm selected would have approx. 8 weeks to complete their preparation before start of e-voting by the members.

Proposals are hereby invited from interested parties who have the capability and experience of conducting e-voting electoral processes. Those desirous of participating in this bid process are required to submit their proposal in the following format:

Format for submitting Bid proposal

- Company profile - Experience (in years) in conducting e-voting, company turnover, details of e-voting conducted in the last 5 years and value of each of such project undertaken, any instance of the company having been debarred from completing the project(s) and reasons thereof.
- An undertaking that the company is not currently involved in any legal dispute that could affect their implementation of the project if selected.
- Detailed Proposal of the e-voting electoral process, timelines for the various steps including security checks to prevent fraudulent voting/duplicate voting, electronic counting, and declaration of results.
- Financial bid to be provided with detailed breakup of the financial quote made in the bid proposal. All bids are to be duly signed by the person authorized to represent the company/firm.
